**Transcript Preparation Fees**

Effective Monday, July 15, 2013, the following fee schedule shall apply for preparation of Court transcripts of proceedings in the Juvenile Division of Lucas County Common Pleas Court.

The fee for preparation of a transcript in a delinquency/criminal matter shall be \$3.25 per page for the original, and \$.05 per page for additional paper copies.

The fee for preparation of a transcript in a civil matter shall be \$4.00 per page for the original, and \$.05 per page for additional paper copies.

The fee for preparation of a transcript from an electronic recording in a delinquency, criminal or civil matter shall be \$4.50 per page for the original, and \$.05 per page for additional paper copies.

The fees for preparation of an expedited transcript in any matter shall be as follows:

Transcript preparation the same day as the proceeding - \$7.00 per page

Overnight transcript preparation for a proceeding the following day - \$6.00 per page

Transcript preparation within forty-eight (48) hours - \$5.00 per page

In all cases, the fee for the original transcript shall be charged one time only, and electronic copies of filed transcripts shall be provided at no charge.

This transcript fee schedule is effective for all transcript requests filed on or after July 15, 2013.
