## **SUBCOMMITTE REPORTS**

## **Executive Committee**

Tim O'Brien updated the LEPC regarding the ownership transfer of one (1) LEPC spill trailer and all the physical assets therein Sylvania Township Fire and Rescue Department. Written resolution 2014-002 was read out loud by Greg Bonfiglio. Discussion ensued.

## **Grants Coordinator**

Mike Frey updated the committee regarding two LEPC grants. The State Emergency Response Commission (SERC) has awarded LEPC \$54,112.00 SERC grant covers expenses such as hazardous materials planning, training, and exercises.

The LEPC was also awarded \$3,600 for Hazard Analysis and \$1,600 reimbursement for facility site visits.

#### **Exercise Committee**

Aletha Reshan updated the LEPC regarding the September 24, 2014 LEPC Emergency Operations Center exercise. Objectives include; EOC operations, population protective actions, public information, traffic and access control.

#### **Plan Review Committee**

Mike Frey informs the LEPC that the revised 2014 hazardous materials plan needs to be formally approved by this group before submittal.

#### Motion

Motion was made by Keith Jackson and seconded by Mike Gerber for the Lucas County Local Emergency Planning Committee to adopt the Hazardous Material Emergency Response Plan as the official document for all hazardous materials response within Lucas County.

#### **Industry Outreach Committee**

Tim O'Brien discussed 2014 Industry Workshop will be held either November or December 2014 Two topics to be presented are; changes in reporting requirements and USEPA Risk Management Plans (RMP).

#### **NEW BUSINESS**

<u>Ohio EMA Restructuring</u> Pat Moomey reports that the Ohio EMA is decentralizing their office into 5 district offices. The regional office for Lucas County will be located in Findlay. Each district office will have 4 Ohio EMA employees

<u>Lucas County EMA Emergency Operations Plan vs. LEPC HAZMAT Plan</u> Mike Frey recommends to the Committee the LEPC could support the EMA plan with a LEPC hazardous materials annex. As a consolidated document, the by-product of this new document synthesis would improve common operation costs and associated joint costs.

Additional compensation to the LEPC Contractor is necessary as this data is outside the course and scope of prescribed job functions to the LEPC. Additional information will be available at the November's LEPC meeting. Discussion ensued

Ohio EPA Restructuring Mike Gerber announced the formation of an Ohio EPA Strike Team This group includes deployable technical experts, specialized equipment and incident management capabilities to respond to any large-scale EPA incident within the state.
