TRANSFER OF OWNERSHIP CERTIFICATE

SECTION 955.11(B) (E) OF THE OHIO REVISED CODE REQUIRES THE FOLLOWING:

UPON THE TRANSFER OF OWNERSHIP OF ANY DOG, THE SELLER OF THE DOG SHALL GIVE THE BUYER A TRANSFER OF OWNERSHIP CERTIFICATE THAT SHALL BE SIGNED BY THE SELLER. A TRANSFER OF OWNERSHIP SHALL BE RECORDED BY THE AUDITOR UPON PRESENTATION OF A TRANSFER OF OWNERSHIP CERTIFICATE THAT IS SIGNED BY THE FORMER OWNER OF A DOG AND THAT IS ACCOMPANIED BY A FEE OF FIVE DOLLARS. PRIOR TO THE TRANSFER OF OWNERSHIP OR POSSESSION OF ANY DOG, UPON THE BUYER'S/TRANSFEEE'S REQUEST, THE SELLER/TRANSFEROR OF THE DOG SHALL GIVE TO THE PERSON A WRITTEN NOTICE RELATIVE TO THE BEHAVIOR AND PROPENSITIES OF THE DOG.

IF THE SELLER/TRANSFEROR OF THE DOG HAS KNOWLEDGE THAT THE DOG IS A DANGEROUS OR VICIOUS DOG, THE SELLER/TRANSFEROR SHALL GIVE A COMPLETED COPY OF THIS CERTIFICATE WHICH SERVES AS A WRITTEN NOTICE RELATIVE TO THE BEHAVIOR AND PROPENSITIES OF THE DOG TO THE FOLLOWING PERSONS OR AGENCIES WITHIN TEN DAYS AFTER THE TRANSFER OF OWNERSHIP OR POSSESSION OF THE DOG:
